On January 10, the committee had removed Alok Verma from the post of director over charges of corruption and dereliction of duty in a 2-1 decision. Kharge had expressed dissent over Verma's removal.

केंद्र सरकार ने शुक्रवार को अंतरिम बजट में दिल्ली के लिए 1,112 करोड़ रुपए का प्रावधान रखा है और केंद्रीय कर और शुल्कों में उसके हिस्से में बदलाव नहीं किया गया है। वित्त मंत्री पीयुष गोयल की ओर से शुक्रवार को लोकसभा में पेश 2019-20 के बजट में दिल्ली सरकार को केंद्रीय सहायता के रूप में 472 करोड़ रुपए देने का प्रस्ताव है। दिल्ली सरकार ने केंद्रीय करों में हिस्सेदारी नहीं बढने पर नाराजगी जताई है।

पिछले बजट में केंद्र ने कुल 790 करोड़ रुपए का आबंटन किया था जिसमें दिल्ली सरकार को केंद्रीय सहायता के तौर पर 499.99 करोड़ रुपए की राशि आबंटित की गई थी, जबकि वित्त वर्ष 2019-20 के अंतरिम बजट में आम आदमी सरकार को 10 करोड़ रुपए 1984 के दंगा पीड़ितों को बढ़ा हुआ मुआवजा देने के लिए भी दिए गए हैं। 2018-19 के बजट में भी इतनी ही राशि दी गई थी।

केंद्रीय वित्त मंत्री पीयूष गोयल ने शुक्रवार को पेश अपने अंतरिम बजट में स्वास्थ्य क्षेत्र के लिए 61,398 करोड़ रुपए के बजटीय प्रावधान की घोषणा की। इसमें 6400 करोड़ रुपए केंद्र की महत्वाकांक्षी 'आयुष्मान भारत योजना' के लिए आबंटित किए गए हैं। आने वाले वित्त वर्ष के लिए स्वास्थ्य आबंटन पिछले दो वित्त वर्ष में सर्वाधिक है। इसमें 2018-19 के आबंटन की तुलना में 20 फीसद बढ़ोतरी का अनुमान था जिसे करीब-करीब पूरा करते हुए मंत्री ने इमसें 16 फीसद की वृद्धि की है। पिछले साल यह आबंटन 54,302.50 करोड़ रुपए था।

वित्त मंत्री पीयूष गोयल ने शुक्रवार को लोकसभा में बजट पेश करते हुए कहा कि 'आयुष्मान भारत योजना' के शुरू होने के बाद से इसके तहत मुफ्त उपचार की सुविधा से करीब 10 लाख लोगों को लाभ हुआ है। इससे उनको इलाज खर्च में 3000 करोड़ रुपए की बचत हुई है। गोयल ने कहा कि सरकार जन औषधि केंद्रों के माध्यम से सस्ती दरों पर दवाएं मुहैया करा रही है और लाखों गरीबों और मध्यम वर्ग के लोगों को आवश्यक दवाएं, स्टेंट और नी इम्प्लांट सहित दूसरे उपकरण सस्ते दामों पर मिल रहे हैं। उन्होंने कहा कि हमने दुनिया का सबसे बड़ा स्वास्थ्य देखभाल कार्यक्रम 'आयुष्मान भारत योजना ' शुरू की ताकि देश के करीब 50 करोड़ (गरीब) लोगों को अच्छे चिकित्सा उपचार की सुविधा मुहैया कराई जा सके।


